## Key responsibilities

### Key responsibilities will include:

- Support the Product Manager in design, development, review, on-going monitoring and maintenance and refresh of EUS products and services to ensure they remain valid and relevant
- Responsible for an assigned portfolio of EUS products and services throughout their whole product lifecycle ensuring review cycles are adhered to
- Development of associated materials, examples including Scheme Rules, Technical Specifications, Delivery Support Materials and Assessments for assigned portfolio including current and new technology to support delivery, learning and assessment, eg CBL
- Liaison with internal colleagues to ensure compliance with quality assurance requirements, efficient operational delivery and continued customer satisfaction
- Leading and facilitating on associated internal and external groups, drawing out product and service improvements/redesign that keep us at the leading edge of employer choice
- Recruitment and on-going management of third party Associates to assist in product, service, materials and assessment development
- Effective engagement & management of external stakeholders to ensure external scheme affiliations are developed and maintained in assigned portfolio, for example eg Construction Skills Certification Scheme (CSCS), Water Industry Registration Scheme (WIRS) and awarding organisations
- Managing the handover of new schemes to operational delivery
- Ensure all documentation is stored in the EUSR documentation system (currently Docuware), by maintaining the consistency of information stored and identifying any key changes through effective configuration management and version control for assigned portfolio
- Working with the Marketing and Communications team to ensure launch plans and on-going communication – internal and external – is included within any development project plan
