

Vocational Education Qualifications-Assessor Qualifications

When NVQs were introduced in the 1980s it was agreed that adults in work settings should not have to attend training courses in order to become vocationally qualified – instead they should be assessed, as far as possible, in their own job, in their place of work, and this principle sustains to this day.

The first iteration of assessing qualifications for these National Vocational Qualifications were the D32 (Assessor) D33 (Lead Assessor and Internal Verifier) D34 Lead Internal Verifier etc. These qualifications were strong on the ethics of assessors and to systematise assessment processes.

Qualifications were registered on the National Qualifications Framework (NQF)

After the NVQ system had been embedded these were reformed as part of a general reform and broadening of qualifications in order to achieve a comprehensive raising of standards.

Assessing Qualifications

- A1 Assessor Qualification which focused on the quality of assessment and the quality of evidence upon which decisions were made
- V1 Internal Verifier with a focus on an inspectorial role people were virtually second assessing to ensure quality of evidence and judgement
- V2 External Verifier an awarding body role which inspected assessment centres across the range of provision for quality systems and standardisation of evidence

The NQF was replaced by the Qualifications and Credit Framework (QCF) which introduced the use of credits and credit structures as part of the European transferability project which began in Higher Education. The EQF was established as the benchmark for levels and vocational qualifications were linked to awards, certificates and diplomas.

With this reform Assessor Qualifications have evolved also and now they confirm to these systems and structures. The QCF has been replaced by the Regulated Qualifications Framework (RQF) which includes credit rated and non-credit based qualifications.
