#### **UK Government announces 25% levy transfer in apprenticeship reform package**

The Treasury's reforms include increasing the amount of unspent funds to the supply chain from 10% to 25%, £5m extra funding for the Institute for Apprenticeships (IfA) to introduce new standards and update existing ones and to consult on the operation of the levy post-2020.

Philip Hammond has tasked the National Infrastructure Commission with carrying out a study into the regulators of telecoms, energy and water following his speech at the Conservative Party Conference. A Junior Treasury Minister also suggested that they could be merged into a single watchdog.

### Welsh Assembly release briefing on water industry in Wales

The Senedd briefing provides an overview of the water industry, including relevant legislation, the devolution settlement, Welsh Government policy and the roles and responsibilities of key organisations. [Read more.](#)

### Committee calls for water regulation review and for compulsory smart metering by late 2019

The Environment, Food & Rural Affairs Committee has released a report on regulation of the water industry, suggesting that by the end of 2019 water companies should be allowed to implement compulsory smart metering and that Government should commission an independent review of whether the industry and regulation are fit to meet future need. ### Institute for Apprenticeships (IfA) consults on T Level content

### Help shape National Occupational Standards and qualifications in water

Energy & Utility Skills' programme of reviews for National Occupational Standards (NOS), Scottish

#### **Developing a new curriculum for Wales**

The Children, Young People and Education Committee at the National Assembly for Wales is seeking written evidence on the progress and development of a new curriculum for Wales. The deadline for responses is 7 December 2018 at 5pm. [Read more](#).

#### **Consultation on ethnic pay reporting**

Views are being sought on how much information should be reported by employers to help address the disparities in pay and promotion opportunities between different ethnic groups that were found in an audit last year. The deadline for responses is 11 January 2019. [Read more](#).

#### **Chief Economist announced as Industrial Strategy Council Chair**

Andy Haldane, the Bank of England's Chief Economist, is to be appointed the Chair of the Industrial Strategy Council. The independent Council will monitor the progress of commitments in the Industrial Strategy. [Read more](#).

#### **80% of employers confused over apprenticeship frameworks and standards**

#### **Labour leader vows to create 400,000 new green jobs**

Jeremy Corbyn MP, Labour Party leader, announced plans to create 400,000 new skilled jobs with fresh investment in wind farms and insulation for homes, in his Party conference speech. He reiterated Labour's commitment to reduce the UK's net carbon emissions by 60% by 2030. [Read more](#).
