Delivering the Power Skills Scheme

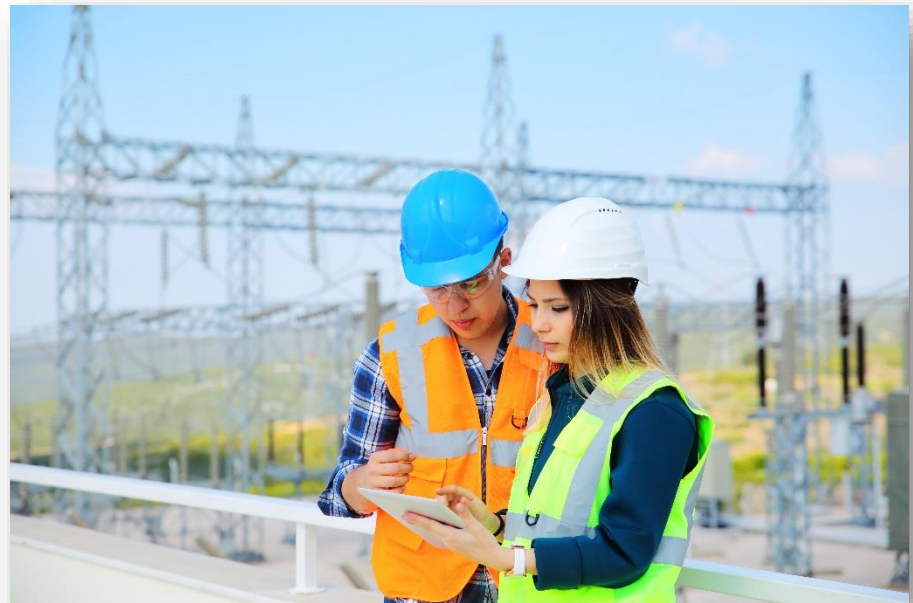

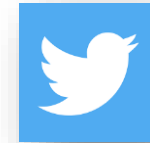
